Personal Injury Case Timeline

Each personal injury case at Herrman and Herrman PLLC starts with an initial meeting between one of our attorneys and the individuals involved to discuss the circumstances of the injury, their legal options, and whether pursuing a lawsuit is the right choice.

After confirming our law firm is right for the client, we will explain the contingency fee arrangement and have our client sign a retainer agreement to formalize the representation.

Next, the attorney and their team investigate, gathering evidence like medical records and accident details. If appropriate, a demand letter is sent to the at-fault party or their insurance company to begin settlement negotiations.

Insurance companies will deny the claim, respond with a counter-offer, or accept liability. Our experienced attorneys then assess the fairness of the settlement offers. If unfair, the attorney will begin the process of filing a lawsuit.

After filing a lawsuit, the case leaves negotiations and enters the discovery phase. This phase may take six months to a year. Both sides gather evidence and take depositions from witnesses. Most cases settle before being tried in court.

If the case must go to trial, our team is ready. Once at trial, the case will be presented to a Texas Judge and civil jury. The trial will include jury selection, witness testimony, closing arguments, and ultimately a verdict.

If successful, damages awarded by the court may need further steps to collect if the defendant refuses to pay. Defendants may also appeal a verdict or damages. Complications like these are why experienced legal guidance is critical. Herrman and Herrman PLLC can navigate the appellate process and uphold the client's rights to seek compensation.

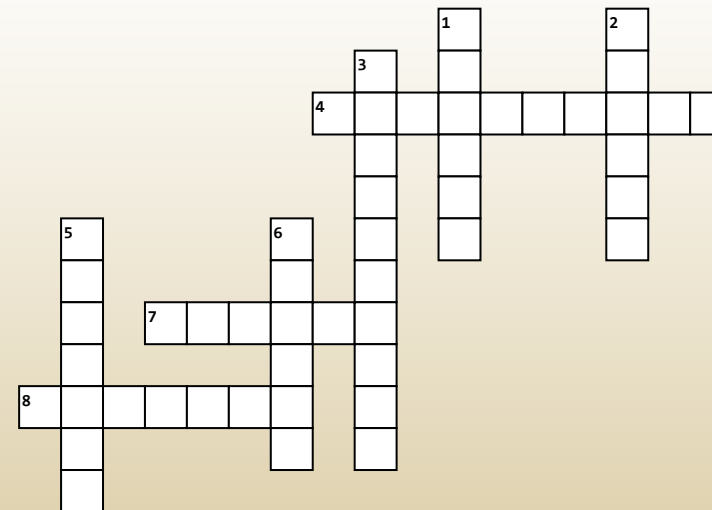
