DRIVING MYTHS DRIVING IN COLD WEATHER

Here in Texas, our winters are mild compared to other places in the United States. However, we still do experience a drop in temperature and at times, even freezing conditions. Although these weather patterns are rare, we should all be prepared for such weather. Here are two dangerous myths to avoid while driving in cold weather.



MYTH #1 - LET YOUR VEHICLE WARM UP

The first piece of advice you often hear about driving in cold weather is to “let your vehicle warm up.” Now while it may be nice get into a warm car as opposed to one that is freezing cold, there is no evidence to support this theory. Some believe a cold start or driving with the car still cold may damage the engine and moving parts, but warming up your vehicle provides no benefit other than your own comfort. You are only burning more fuel and costing yourself more out of pocket expenses. However, you may deem those negatives actually worth it depending on how cold it is outside.

MYTH #2 - PARKING BRAKE TO HELP STOP



The second myth for driving in cold weather is that your parking brake should be used to help your vehicle stop. This is a lesser-known myth and that’s a good thing. By using your parking brake in icy conditions you’re actually negating your anti-lock braking system and that can be very dangerous. Most vehicles on today’s roads are equipped with anti-lock brakes and for good reason. Anti-lock brakes are a much safer alternative to the old brakes that used to come on our vehicles. Also, the parking brake is more likely to freeze in the event of very cold weather. So if you need to suddenly make an emergency stop and use the parking brake, there is a chance it will fail and you will not be able to stop your vehicle in time.

So while extreme cold weather is not common in Texas, it is important to avoid these myths to stay safe on the road.

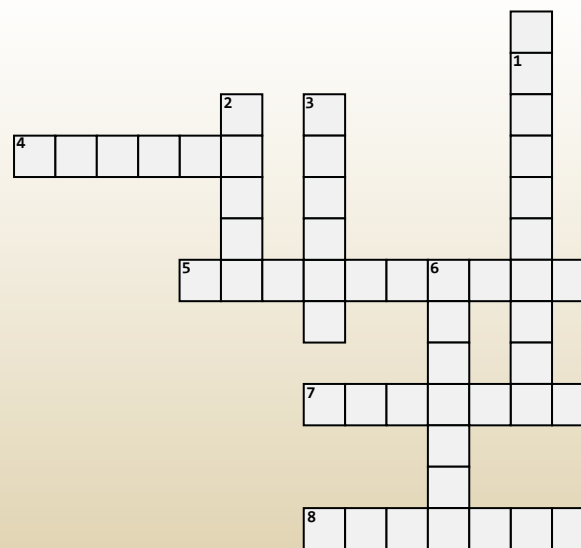
