WHAT TO DO AFTER A CAR ACCIDENT

- Collect names, phone numbers, insurance details, and vehicle descriptions of all involved parties.

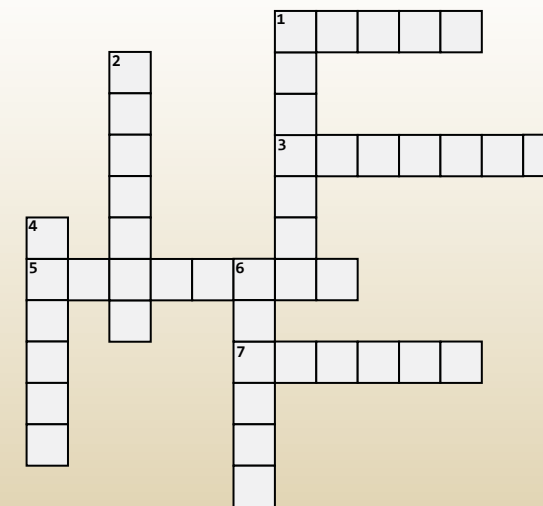
